

## The Energy Policy Act of 2005

VELUX skylights and SUN TUNNEL™ skylights may qualify for up to \$200 federal tax credit for existing homes under the Energy Policy Act of 2005.\*

### Homeowner requirements:\*

- Purchase a qualifying VELUX skylight or SUN TUNNEL™ skylight and keep a copy of the receipt for product
- Keep the ENERGY STAR® label from the product with receipt
- Install before January 1, 2010
- Claim a federal tax credit for the year of purchase and installation (excluding 2008)

### Limitations:\*

- Credit amount is 10% of the amount paid for all qualifying windows, skylights and SUN TUNNEL™ skylights with a maximum credit of \$200
- Installation costs do not qualify for credit
- Purchases and installations in 2008 do not qualify
